# **RENTAL FEES**

RESERVATION FEES ARE <u>NON-REFUNDABLE</u>
RESIDENTS \$20.00 PER 3 HOUR BLOCK OF TIME
NON-RESIDENTS \$40.00 PER 3 HOUR BLOCK OF TIME

# **CLEANING DEPOSIT**

\$100 - MUST BE IN THE FORM OF A CHECK OR MONEY ORDER
REFUNDABLE IF PARK FACILITIES ARE CLEANED TO THE SATISFACTION OF THE PARKS SUPERVISOR
CLEANING DEPOSIT MAY BE HELD, BUT IS NOT LIMITED, FOR THE FOLLOWING:

- ALL TRASH NOT LEFT SECURELY IN TRASH RECEPTACLES
- ALL TAPE AND DECORATIONS NOT REMOVED
- VEHICLES IN PARK
- ALCOHOL, CIGARETTES IN PARK
