It is important to note that the City has the land to accommodate the RHNA numbers at all income levels with a bit of a buffer. There are five primary goals that the City must work to achieve for the duration of this element.

SCHIFFMAN at the time the study was being conducted, the 2020 data wasn't available. Also, the data regarding wastewater is outdated.
