SUBJECT: DISCUSSION/ACTION: CONSIDERATION TO ALLOW THE "IMPERIAL VALLEY LAW ENFORCEMENT RELAY RUN" TO HOLD ITS EVENT WITHIN CITY LIMITS 1. AUTHORIZATION FOR EL CENTRO SECTOR U.S. CUSTOMS AND BORDER PROTECTION TO HOLD ITS ANNUAL IMPERIAL VALLEY LAW ENFORCEMENT RELAY RUN WITHIN CITY LIMITS

BACKGROUND/SUMMARY: El Centro Sector U.S. Customs and Border Protection is scheduled to hold its Annual "Imperial Valley Law Enforcement Relay Run" on Saturday, May 15, 2021 during National Police Week. The run starts at 6AM and ends at approximately 10AM. The border patrol acquires a County encroachment permit for the run and requests approval from City Council to hold its relay within city limits. Safety vehicles are required for each team. The 24-mile relay is run by co-ed teams consisting of 10 law enforcement officers with approximately 15 teams participating; 10-15 officers run at each leg. Each team runs in honor of a fallen officer with the officer's name engraved on the baton that is carried throughout the race. This baton is presented to the surviving family following the run. <u>Legs</u> Leg 1- 3 mi/NE side of BP station to Aten and Old Highway 111 Leg 2- 1.5 mi Aten/Old 111 to Worthington Leg 3- 2.5 mi Worthington/Old 111 to Harris Leg 4- 3 mi Harris/Old 111 to Carey Road Leg 5- 2 mi Carey Rd/Old 111 to Mead Leg 6- 2 mi Mead/Old 111 to Carey Rd Leg 7- 3 mi Carey/Old 111 to Harris Leg 8- 2.5 mi Harris/Old 111 to Worthington Leg 9- 1.5 mi Worthington/Old 111 to Aten Leg 10= 3 mi Aten/Old 111 to ECBP station
