SUBJECT: DISCUSSION/ACTION: ACCEPTANCE OF ADDITIONAL SEVEN (7) FEET RIGHT-OF-WAY ADJACENT TO THE SOUTH RIGHT-OF-WAY LINE OF ATEN BLVD. BETWEEN MYRTLE ROAD AND LaBRUCHERIE ROAD. 1. ACCEPTANCE OF ADDITIONAL SEVEN (7) FEET RIGHT-OF-WAY.

BACKGROUND/SUMMARY: The City of Imperial is currently developing a pedestrian improvement project to increase both, the safety and the mobility of our residents by constructing new concrete sidewalks along the south side of Aten Boulevard between Myrtle Road and LaBrucherie Road.  Existing Right-of-Way along the south side of Aten Boulevard is not sufficient to complete the proposed improvements. The amount of right of way needed for this project is an additional seven (7) feet section.  Property owners of the following parcels are willing to assist the City by dedicating the needed right of way along the above-referenced section:  064-351-003, 064-351-004, 064-351-019, 064-351-022, 064-351-023, 064-351-026, 064-351-028, 064-351-030 & 064-351-032. Exhibits 1 and 2 attached herewith illustrate their location.  For your review and acceptance, attached are the documents prepared by the Community Development Department for dedication of the needed right of way.
