SUBJECT: DISCUSSION/ACTION: EMERGENCY REPAIRS TO COLLAPSED SEWER LINES AT CITY HALL.

1. ADOOPT RESOLUTION NO. 2019-28, DECLARING AN EMERGENCY AND AUTHORIZING CITY MANAGER TO TAKE SUCH ACTION NECESSARY IN RESPONSE THERETO.

DEPARTMENT INVOLVED: City Manager and Pubic Services

BACKGROUND/SUMMARY:

The sewer lines underneath the city hall/police department building are in various stages of failure. Main sewer lines have collapsed which has resulted in all restrooms become non-operational. Several attempts to unclog the lines have been unsuccessful. Being presented is a remedial proposal to repair the sewer lines leading to the restrooms so that they will become operational again. This will provide the ability to stay operational for the next few years. This is not a life-long/permanent fix but is warranted for 10 years.

RESOLUTION NO. 2019-28

RESOLUTION DECLARING AN EMERGENCY, RATIFYING ACTION TAKEN BY THE CITY MANAGER AND AUTHORIZING THE CITY MANAGER TO TAKE SUCH FURTHER ACTION AS MAY BE NECESSARY IN RESPONSE THERETO

WHEREAS, the city owns the building located at 420 South Imperial Avenue which houses the Police Department and City Administration offices; and

WHEREAS, the building was constructed in 1939 of concrete as a detention facility; and

WHEREAS, due to the age of the building and construction nature of the building, the sewer lines have deteriorated over time causing the collapsing of these lines; and

WHEREAS, these damaged sewer lines are not able to be repaired or replaced without significant structural modification or demolition of portions of the buildings; and

WHEREAS, because of the health and safety concerns to employees and the public, such emergency would not reasonably permit delays associated with a competitive solicitation for bids and the action authorized herein is necessary to respond to the emergency; and

WHEREAS, in order to safeguard the public health and safety and to protect property, it is necessary to take immediate action to repair the damaged sewer lines; and

WHEREAS, the City Council wishes to ratify any action taken to date by the City Manager to address the condition described herein and further wishes to approve the repair by Specialized Pipe Technologies in an amount not to exceed \$40,000.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The above-referenced recitals are true and correct and are incorporated herein.
- 2. The City Council declares that the public health and safety and necessity demand the immediate expenditure of public money to safeguard life, health or property, and hereby ratifies any action by the City Manager to repair the collapsed and deteriorated sewer lines.
- 3. The City Council, in order to safeguard life, health or property, hereby approves the repair of the City Hall sewer lines by Specialized Pipe Technologies in the amount not to exceed \$40,000.
- 4. The City Council authorizes action set forth herein on the basis that the emergency described herein will not permit delay resulting from a competitive solicitation of bids and the action is necessary to respond to the emergency.
