Alliant Consulting - \$8,750 All proposals received have a vast knowledge of labor compliance monitoring; however, Legion Consulting seems to be the most advantageous to the city.

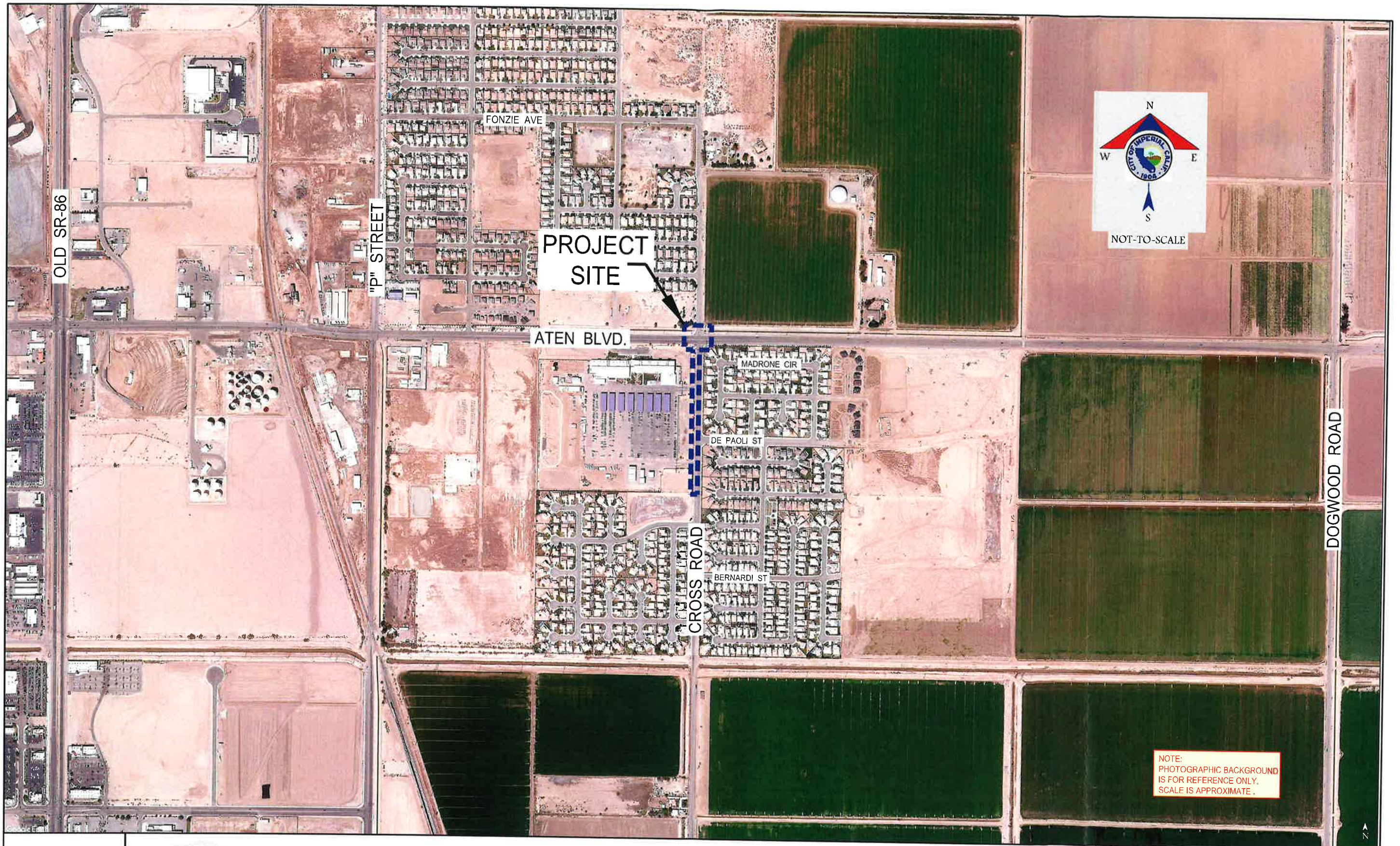
