	Subject: Payment for DMV Physical Exams for Class A and Class B Licenses
	In consideration of the mutual covenants and agreements contained herein, the parties agree a follows:
1.	The City agrees to pay for the cost of DMV physical exams for the Class A or Class B license for those staff whose job classification requires such licenses be maintained in order to perform their job duties.
2.	Employees will request a DMV physical appointment through the Human Resources Department
3.	The Human Resources Department will schedule an appointment for the employee to attend the DMV Physical with the City's occupational medicine provider.
4.	The City will be invoiced directly by the occupational medicine provider for the cost of the appointment, at no cost to the employee.
	This Side Letter Agreement will be presented to the Imperial City Council and shall be effective upon approval of the Imperial City Council on November 15, 2023 and shall remain in effect for the duration of the Collective Bargaining Agreement between the City of Imperial and Teamster Local Union No. 542 ending June 30, 2026.
