ADDENDUM No. 1

TO THE CONTRACT DOCUMENTS AND SPECIFICATIONS.

Bidders are advised that the contract documents and specifications for the above referenced contract are hereby amended in the following manner and the following manner only:

This Addendum answers bidder's questions asked during Pre-BID meeting on 12/05/2023:

1. **Could the timeframe for the completion of the scope of work be extended from the original time of 30 consecutive calendar days?**

ANSWER: Yes, the time of completion has been increased to be 45 consecutive days after the date of the Notice to Proceed.

2. **Based on observations on site, will a grading plan be provided to the contractor as part of the documents to complete the work?**

ANSWER: The City has prepared and attached to this addendum the Exhibit B: Typical Regrade Detail.

3. **Is it feasible, safety wise, to install a 4 ft tall fence with barb wire?**

ANSWER: Description for Item # 9 remains with no changes: “4’ HEIGHT GALVANIZED PRIVACY-LINK (INSERTED SLATS) FENCE WITH (3) STRANDS OF BARBED WIRE”.

4. **Is there a Buy American stipulation in the contract, and what are the specifications of the materials, to ensure all the bidders will compete in the same grounds?**

ANSWER: The Buy American stipulation can be found on page 9 of the “Contract Documents and Specifications for HWY 86 FENCE REPLACEMENT PROJECT FROM 2ND STREET TO MARSHALL AVENUE”. As for the specifications for the materials, they are to be found on pages 97-104 of the above-mentioned document. All steel must be commercial grade (ex. All posts must be gauge 40).

5. **Will Traffic Control be required if the work could be done from the inside of the Fair Grounds?**

ANSWER: Yes, the contractor shall prepare/implement traffic control plan.

6. Is the fence located within the City's Right-of-Way?

ANSWER: The new chain-link fence along Old SR-86 will be installed over the property line per Bid Item 4 (Construction Staking).

7. If there's the need for a permit, will the City provide it?

ANSWER: City to waive the fees associated to this project (Permits, inspections, etc) within the City's Right-of-Way.

8. Is the City going to conduct inspections?

ANSWER: Yes, the City will be conducting daily inspections. One day advanced notice is required for Inspection scheduling.

9. Could the material be left on site, and could the City provide a yard for the materials to be left on?

ANSWER: The City will not provide a special location to store any materials. However, the contractor may use the following information to contact the County Fairgrounds to negotiate an arrangement to leave the materials within the Fairgrounds:

10. What is the accuracy of the dimensions shown in the exhibit, and in case that the dimensions are different, will the City adjust the prices to the actual dimensions?

ANSWER: City to pay the contractor based on field measured dimensions.

11. If the work is done from the easterly side of the fence (within the Imperial Valley Fairgrounds) will Traffic Control still be necessary?

ANSWER: Yes, since part of the targeted work falls inside the City's Right-of-Way, a Traffic Control will be mandatory, to prevent any accident and alert drivers along Old SR-86 of the works.

12. **Will the gates be necessary, what type of gates should be used and where is its location?**

ANSWER: The scope of the work includes the installation of a gate, the specifications of the gate to be located are found inside the Contract document, and the location of the gate is, approximately, 1,210' north from Marshall Avenue.

13. **What is the type of license required for the job?**

ANSWER: A Class A or any combination of "C" licenses that satisfy the requirements of the job.
